## Reflections on the "Weak Flesh" operation

Globalization is, by definition, a process that enables the integration between economies, cultures, environments, and markets of different countries. According to Abílio1, today's society is built around flows: capital flows, information flows, technology flows, flows of organizational interaction, flows of images, sounds, and symbols.
